Effective date

20 June 2022

1. This is an announcement that LTA will launch a registration scheme for Transport Impact Assessment (TIA) consultancy firms in Singapore with effect from 20 June 2022.
2. This scheme recognises and registers TIA consultancy firms known to have the capability to produce quality TIAs and maintain high standards.
3. The registration scheme is not mandatory. TIA consultancy firms capable of producing quality TIAs have already been advised/recommended to register for the scheme to facilitate easy reference by the industry.
4. From 20 June 2022, LTA will publish the list of registered TIA consultancy firms on LTA websites at this URL: <https://go.gov.sg/listofregistereditiafirms> The industry is encouraged to refer to the published list when selecting/appointing a TIA consultant.
5. Relevant professional institutions/associations are encouraged to include this weblink in their websites for members ease of access.
6. The list of registered TIA consultancy firms will be updated when there is a change of firms registered on the list. Registered TIA consultancy firms that fail to produce quality TIAs¹ will be removed from the list.

¹ The TIA Guidelines and its addendum provide outlines on the requirements of a quality TIA submission.
