1. REDAS President Mr Chia Boon Kuah will be leading a delegation of property developers and business associates to Jakarta from 15 –17 May 2013. The focus of the trip is to gain a deeper understanding of the real estate development and the opportunities in Jakarta and Indonesia.
2. The trip will include visits to development sites as well as meetings with Indonesia's Investment Coordinating Board, BKPM, courtesy call to the Governor of Jakarta, networking session with Realestat Indonesia and a golf game @Senayan Club (optional). Through the meetings with government, city and REI officials and site visits, we hope to forge closer ties with our Indonesian counterparts.
3. **The Programme** will be arranged as follows :
  - 15 May** Visit selected completed projects and development sites;
  - 16 May** Meeting with Indonesia's Investment Coordinating Board, BKPM;

  - 17 May** City tour and visit development sites / Return to Singapore
