



DEVELOP A RISK MANAGEMENT IMPLEMENTATION PLAN FOR WSH & TRAFFIC SAFETY MANAGEMENT (WDA APPROVED COURSE CODE: MF-COM-402E-1)

Course Overview

Jointly organised by Associates Consulting and REDAS, this course will equip participants with the knowledge and skills to be a Risk Management (RM) Team Leader / Champion for the organisation in reducing WSH & traffic management risks at source by managing the risk management process at the workplace.

It involves developing a practical “**Risk Management Implementation Plan for WSH & Traffic Safety Management**” for the organisation which identifies specific actions to be taken, by whom and time for their completion. It also entails the formation of a risk management team, risk assessment, controlling and monitoring the risks, communicating these risks to all persons involved and in compliance with the Risk Management Code of Practice (RMCP).

Participants, who have successfully completed the course, will be issued a Certification of Attainment by WDA and qualifying them to apply for the bizSAFE Level 3 certification programs. For more details, please refer to attached **Course Schedule**.

Why is it important to you?

All business owners and/or senior management staffs must **prove** their “due diligence”, should an accident occurs in the workplace. It is for this reason that you need to train your staffs in workplace safety and health & traffic safety management.

Requirements under Workplace Safety And Health (Risk Management) regulations

- 3.—(1) ...the employer, self-employed person and principal shall **conduct** a risk assessment in relation to the safety and health risks posed to any person who may be affected by his undertaking in the workplace.
- 6.—(1) ...the employer, self-employed person and principal shall...**ensure**...person in the workplace...is informed of the nature of the risk involved and any measure or safe work procedure implemented...

Why is there a need to manage traffic accidents in the workplace?

- 19 workplace fatalities in the first quarter of 2014 and MOM is undertaking a further review of its regulatory penalties and the legislative framework for WSH infringements.
